Should You Disable Amazon Sidewalk And Apple Find My?

Amazon Tile Trackers and Apple AirTags are so convenient. Amazon Sidewalk and Apple Find My "crowdsourced" networks help users find lost objects that the Tiles or AirTags devices are attached to. This technology makes finding lost things extremely easy. Apple AirTags only cost \$29 each and Amazon Tiles range in cost between \$24 and \$59 in several styles. The user attaches the Tile or Airtag to cellphones, laptops, keys, wallets, dog collars, or places them inside objects. What kind of crazy person would recommend that a customer disable this technology? Well, there are hundreds of articles on the Internet on why and how to opt-out of Amazon

Sidewalk, and a significant number of articles on the dangers of the Apple Find My network. Yet most articles promote the benefits of the "lost and found" technology and downplay or ignore its major security and privacy problems.

AirTags and Tiles are active RFID tags with a battery inside. Most RFID tags are used in retail stores or warehouses to track inventory and sales of items and are passive, having no internal power source. Some companies also use RFID tags for ID badges and even insert them under the skin of employees to allow access to buildings, access computers, or purchase items. The different types of



Amazon Tile RFID tags are detected from a 150-to-400foot range. Apple AirTags may have a range between 200 and 400 feet, according to some experts.

These RFID tags require a huge number of Internet devices in an interconnected network to be effective. Amazon and Apple already have private networks in place

to achieve this. As Victoria Song of Gizmodo.com pointed out, these are called mesh networks where related devices work together to "extend

Water Shortage Crisis, Hoover Dam Is At Record-Low Water Level

"The water level at Lake Mead, the Colorado River reservoir serving the Hoover Dam, fell to 1,068 ft. in July, the lowest level since the lake was first filled following the dam's construction in the 1930s. This month, the federal government is expected to declare a water shortage on the Colorado River for the first time, triggering cutbacks in water allocations to surrounding states from the river.

If the water level drops 118 ft. from July's level to 950 ft., it would fall below the turbines and the dam must shut down, said Patti Aaron, public affairs officer at the U.S. Bureau of Reclamation.

The power declines are significant. At 1,200 ft. water elevation—where it was in the

year 2000 when water levels were among the dam's highest levels—the dam can power up to 450,000 homes. At the

This Is How Savings And Investment Pave The Way For An Advanced Economy

To maintain his life and well-being, an individual must have at his disposal an adequate amount of consumer goods. These goods, however, are not readily available. Without tools at his disposal and by means of his bare hands, the individual can only obtain from nature very few goods for his survival.

For instance, take an individual named John, stranded in a forest. In order to stay alive, he can only pick up some apples from an apple tree. Apples are the only good available to him that can sustain him. Let us say that by working twenty hours a day, he manages to secure twenty apples, which keep him alive. The twenty apples that John has secured from nature is his subsistence fund, which sustains him (see also on this Rothbard).

John realizes that if he had a special stick this would allow him to become more productive. His daily production of apples could be forty apples (i.e., double his current production). The problem, however, is that the stick is not available – it must be made. To make the special stick requires two days of work. If John were to decide to make the stick, he would have a problem. By spending

his time on making the stick, he would not be able to pick

up the apples that are required to keep him alive.

The only way out of this predicament is for John to put aside an apple a day for the next forty days. By saving an apple out of his daily production and enduring hunger, after forty days he will have an adequate stock of apples that will

sustain him while he is busy making the stick. (We make the unrealistic assumption here that apples can be preserved in edible form for forty days). Thus, after forty days, John's subsistence fund will be comprised of forty apples, which will see him through while he is making the special stick. We can see here that the saved or unconsumed forty apples enable the making of the stick, which raises the production of apples and lifts John's living standard.

Note that the making of the stick is a burden – John has to make a sacrifice and save forty apples thereby endangering his health and well-being. However, the stick will allow

him to double his production of apples. If he continues to



consume twenty apples a day, this will allow John to increase his subsistence fund. With a larger fund, John could consider allocating his time to make some other tools to enhance his life and wellbeing.

The state of the subsistence fund determines the quality and the quantity of various tools that can be made. If the fund is only sufficient to support one day of work, then the making of a tool that requires two days of work cannot be undertaken. The size of the fund sets the limit on the projects that can be implemented. It also means that the size of the fund determines the so-called

economic growth.

According to Richard von Strigl

"Let us assume that in some country production must be completely rebuilt. The only factors of production available to the population besides laborers are those factors of production provided by nature. Now, if production is to be carried out by a roundabout

method, let us assume of one year's duration, then it is self-evident that production can only begin if, in addition to these originary factors of production, a subsistence fund is available to the population which will secure their nourishment and any other needs for a period of one year.... The greater this fund, the longer is the roundabout factor of production that can be undertaken, and the greater the output will be. It is clear that under these conditions the "correct" length of the roundabout method of production is determined by the size of the subsistence fund or the period of time for which this fund suffices."

The essence of the subsistence fund with respect to an individual, John, can be widened to include many individuals that trade with each other. John, who produces apples, can now secure meat and clothing from other individuals. This means that the subsistence fund is now comprised of a greater variety of final goods ready for human consumption. According to Böhm-Bawerk:

"The entire wealth of the economical community serves as a subsistence fund, or advances fund, and, from this, society draws its subsistence during the period of production customary in the community."

Note that the improvement of the infrastructure enables the strengthening of economic growth. The improvement in the infrastructure in turn can take place *because* of the increase in the subsistence fund. Hence, anything that weakens the subsistence fund undermines the prospects for economic growth.

Money-Laundering Ring Pushed \$4 Billion Through HSBC

A vast money-laundering ring moved \$4.2bn through a network of 60 HSBC accounts in Hong Kong starting only two years after the bank promised to clean up its act, an investigation by the Bureau of Investigative Journalism and the Guardian has revealed.

Insiders have raised questions over whether HSBC appropriately informed US monitors about the ring, which was uncovered by the bank during an internal review. The independent monitoring team was specifically installed by the US Department of Justice (DoJ) as part of a deal not to prosecute HSBC in 2012 when the bank admitted allowing Latin American drug cartels to launder hundreds of millions of dollars through its accounts.

HSBC discovered the Hong Kong ring in 2016 while trying to assess its exposure to the wealthy Gupta family, who have been embroiled in corruption scandal allegations in South Africa. The Guptas have denied any wrongdoing.

While the resulting report concluded that its exposure to Gupta-linked accounts "contained and minimal", HSBC's financial investigations unit ended up raising concerns about "larger professional money laundering networks", including the Hong Kong ring, which it said had processed more than \$4.2bn worth of payments between 2014 and 2017. While much of this sum may not have been "dirty money", laundering often relies on mixing legitimate and illegitimate funds together.

"HSBC never voluntarily disclosed money laundering. They waited to be asked about it," one former member of the monitoring team, who agreed to speak on the condition of anonymity, said. "As far as I'm aware, this particular report ... was never disclosed to the monitor," they confirmed, adding that this appeared to be a bigger money-laundering network than any they had identified at the bank.

Another former official from the team suggested it was likely that the HSBC report "would have made it to board level," adding executives at the bank could have been aware of the suspected network.

HSBC told the Bureau it reported suspected money laundering to local authorities "as appropriate", but the monitor "serves a different disclose the information to the role in helping a bank to independent monitors brought improve its capabilities" and The bank is facing criticism from senior political figures on both sides of the Atlantic, as are regulators for failing to adequately hold executives to

The internal HSBC report was disclosed as part of the Zondo judicial inquiry in South Africa, which is examining claims of high-level corruption involving former president Jacob Zuma and members of the wealthy Indian Gupta family. The Guptas have been accused of alleged bribery, money laundering, and political patronage, which they deny, and became the subject of US sanctions in 2019.

HSBC handed over the report after officials from the inquiry demanded it confirms leaked transactions revealing Guptalinked money had flowed through the bank's accounts. Shadow World Investigations (SWI), a group of non-profit researchers based in London, had used the leak to allege

that in all more than a hundred million dollars had been laundered out of South Africa through Hong Kong and China by various parties.

"The vast flow of funds into and out of South Africa, and through laundry vehicles abroad, raises profound questions about the role of professional enablers in the process of state capture," Shadow World Investigations wrote in a submission to the Zondo commission. "It is vital that the banking sector in South Africa and abroad (and, in the latter case, HSBC in particular), as well as the auditing sector, answer how such large quantities of criminal funds could be transmitted around the world with seemingly little hindrance."

The Markets Next "Minsky Moment"

In 2007, I was at a conference where Paul McCulley, who was with PIMCO at the time, discussed the idea of a "Minsky Moment." At that time, this idea fell on "deaf ears" as markets were surging higher amidst a real estate boom. However, it wasn't too long before the 2008 "Financial Crisis" brought the "Minsky Moment" thesis to the forefront.

So, what exactly is a "Minskey Moment?"

Economist Hyman Minsky argued that the economic cycle is driven more by surges in the banking system and credit supply. Such is different from the traditionally more critical relationship between companies and workers in the labor market. Since the Financial Crisis, the surge in debt across all sectors of the economy is unprecedented.

Importantly, much of the Treasury debt is being monetized, and leveraged, by the Fed to, in theory, create "economic stability." Given the high correlation between the financial markets and the Federal Reserve interventions, there is credence to Minsky's theory. With an R-Square of nearly 80%, the Fed is clearly impacting financial markets.

Those interventions, either direct psychological, support the speculative excesses in the markets currently.

Bullish Speculation Is Evident

Minsky's specifically noted that during periods of bullish speculation, if they last long enough, the excesses generated by reckless, speculative activity will eventually lead to a crisis. Of course, the longer the speculation occurs, the more severe the problem will be.

Currently, we see clear evidence of "bullish speculation" from:

- Due to commission-free trading and mobile apps, retail trading has exploded.
- A surge in IPO's
- A record increase in SPAC's
- Investors paying record multiples and prices for

money-losing companies


- Option contract speculation has seen record increases
- Margin debt at new highs and nearrecord annual increases.
- A widely accepted belief "this time is different," due to the "Fed Put."
- Record M&A activity

But, again, these issues are not new. In one form or another, they have all been present at every prominent market peak

Notably, what fosters these periods of exuberance in markets is "stability." In other words, there are periods of exceptionally low volatility in markets, which breed overconfidence and speculative appetites.

However, these periods of exceptionally low volatility are also a problem.

The Instability Of Stability



Hyman Minsky argued there is an inherent instability in financial markets. As noted, an abnormally long bullish cycle spurs an asymmetric rise in market speculation. That speculation eventually results in market instability and collapse.

We can visualize these periods of "instability" by examining the Volatility Index versus the S&P 500 index. Note that long periods of "stability" with regularity lead to periods of "instability."

Given the volatility index is a function of the options market, we can also view these alternating periods of "stability/instability" by looking at the daily price changes of the index itself.

A "Minsky Moment" is

the reversal of leverage following prolonged bullish **speculation.** The build-up of leverage is the direct result of the complacency occurring from low-volatility market regimes.

One way to at "leverage," as it relates to the financial markets, is through "margin debt," and in particular, the level of "free cash" investors have to deploy. So, for example, in periods of "high speculation," investors are likely to be levered (borrow *money)* to invest, which leaves them with "negative" cash balances.

connectivity." Promoters incorrectly call these networks "crowdsourced" even though many people unknowingly participate.

How do these mesh networks operate? For Amazon, their Ring Video Doorbell home security systems and Echo speakers connect to Alexa voice-based virtual assistant. A small portion of a customer's home bandwidth is used and combines with the bandwidth of other Echo and Ring devices in the local area. This is called parasitic bandwidth sharing. The mesh network fills in the empty spaces of your network's internet connection and devices by utilizing lowpower wireless connections, surrounding your home. The

range of its radio frequency is estimated to be half a mile. Users set up the Amazon Tile App on Android, Windows, or iOS to make Tiles ring or view the Tile's maost recent location when users want to find a lost item.

For Apple, the user sets up the Find My app on an iPhone, iPad, or iPod touch, or Android. When a specific item is lost the person enters it on the Find My app. If the user chooses to Play a Sound and the item is near, the user will hear the device ring. If there is no sound, the user enters View Location to view exactly where the device is on the planet.

The Apple Find My network has approximately 1.65 billion connected devices and so this network is extremely effective in locating lost items. The Sidewalk network of millions of Amazon Ring and Echo devices is probably just as effective. According to cybersecurity expert Rob Brahman, most major US cities are probably fully within the Sidewalk mesh network.

Here are the Amazon devices that extend connectivity through Sidewalk: Echo (3rd gen +), Echo Dot (3rd gen +), Echo Dot for Kids (3rd gen +), Echo Dot with Clock (3rd gen +), Echo Input, Echo Flex, Echo Plus (all gens), Echo Show (all models and gens), Echo Spot, Echo Studio, Ring Floodlight Cam (2019), Ring Spotlight Cam Mount

(2019), and Ring Spotlight Cam Wired (2019).

All this still sounds great. What is the big problem for consumers? Cybercriminals are increasingly gathering people's data and monitoring people's internet devices to steal assets and commit violence. Bad people can use Sidewalk and AirTags to commit crimes against people, regardless of the assurances by Amazon and Apple that they use encryption and have taken measures to protect user privacy and security.

Businesses will also need to increase their security. Fabian to read Braunlein, of Positive Security, commented that although the Apple Airtag bandwidth is

low, it still would allow hackers an effective and inexpensive way to secretly remove data from corporations. Johannes Ullrich, dean of research at the SANS Technology Institute, warned that mesh networks and parasitic bandwidth sharing could be used by hackers to send data. "As far as risks go, you don't know who actually uses your device or what they are using it for. You have no control over who is using your device or how they are using it."



Shrinkflation, Inflation's Sneaky Cousin, Is On The Rise

Inflation has been on the rise for the past year and in the last few months, it has accelerated. In June 2021, inflation, measured by the Consumer Price Index (CPI), hit the highest level since 2008. By inflation, economists refer to the increase in the general level of prices, which means that prices on average are increasing. The Bureau of Labor and Statistics (BLS) has a basket of goods and services that it tracks and uses to create a measure of the CPI. While inflation is the topic of the day in the news media and everyday conversations, many have not heard about its sneaky cousin, shrinkflation.

The term **shrinkflation**, is credited to British economist Pippa Malmgren and refers to the shrinking weight of the products while the price for the package remains the same. This is in effect another form of inflation since the per-unit price of goods increases when products shrink. However, shrinkflation is trickier, since most consumers do not notice it (see here for a few examples of shrinkflation). Shrinkflation is an ongoing process, but we are seeing more of it in the past year, and especially the first half of 2021, as businesses scramble to catch up with increasing costs of production. Shrinkflation is so widespread today that there is a dedicated Reddit page for it.

Many complain about businesses resorting to shrinkflation and regard it as a sneaky way to increase prices. Yet many of the critics do not realize that businesses have no choice but to increase prices. Anyone who is paying attention to prices in the first half of 2021 will know that it is not only the price of consumer goods that it is increasing but also the prices of producer goods. In other words, the inputs used in the production of the goods we consume, including labor, have been getting more expensive. Consequently, businesses in a fight to maintain their profit margins have resorted to increasing prices or shrinking the size or weight of their products.


Normally, the BLS accounts for the weight of the products it tracks, which would allow them to account for shrinkflation, but as the *Washington Post* reports, the BLS has not been able to do this very well during the pandemic. This means that the current inflation measure,

as measured by CPI, is most likely underreporting the extent of current inflation.

What is causing this increase in shrinkflation? Well, since shrinkflation is in fact a form of inflation, the short answer is that the same factors have caused inflation. As you may already be aware, many are blaming shortages and disruptions in the supply chain for the recent increases in inflation, but that hardly explains the whole story.

The two main candidates to blame are the Fed and the government. The Fed has printed tremendous amounts of money, which has led to the doubling of its balance sheet since March 2020. This is in fact what inflation is, and this is the cause of what we normally refer to as inflation, which, to be more accurate, is price inflation. In general, we know that the more money we print, holding all else equal, the more inflation we will get, and that is part of what we are seeing

On the other hand, we have had the federal government spend money at record levels for a peacetime period. This also has led to an increase



of demand beyond what one would expect in the circumstances we have been in since the spring of 2020. For example, retail sales have increased rapidly and have been above trend since late 2020. While some of this can be seen as catching up after the decrease we saw in the second quarter of 2020, it is definitely gone beyond catching up, as is clear from the graph below. Government spending has become a topic of concern even for mainstream economists like Larry Summers, who is now worried about the economy overheating because

Lastly, while the supply chain disruptions are blamed on covid-19, it is the lockdowns


instituted by governments, in the US and other countries, that are the main culprit behind these supply chain disruptions. The problem with the lockdowns was that they completely ignored the costbenefit analysis by arbitrarily determining what constituted an essential business and what did not. As you may well know, one can ignore the laws of economics, but not their consequences, and we are now suffering the consequences of these arbitrary lockdowns.

The Federal Budget Deficit for July 2021 was 302B which was up 73.4% over June and 16.5% above the TTM average of 238B. The chart shows the Federal Budget for the previous 18 months.

Los Angeles City Council Unanimously Passes Legislation To Add 25,000 Homeless Housing Units By 2025

'A Way Home' initiative legislation expected to be paid for by federal homeless funds

The Los Angeles City Council voted unanimously 13-0 to create or add 25,000 housing units for the homeless by 2025.

The new housing dictum, which is part of Councilman Kevin De Leon's "A Way Home" initiative, would utilize existing resources such as Project Homekey and pool together different housing types across the city including scattered-site housing, tiny homes, mobile homes, new apartment units set aside for low-income housing, building conversions to housing, units in safe parking areas, and other forms of permanent supportive housing to reach 25,000 units for the homeless in 4 years time.

To be funded by part of the \$12 billion in federal funds that were allocated to help fight the homeless crisis in California, the 25,000-unit legislation failed to go so far as to set any consequences for not meeting the unit goal by 2025, with Councilman De Leon only saying that the council members would be

held accountable by the ballot box.

"The city of L.A. can hold us accountable now because we must produce come hell or high water, by hook or crook in some form way or shape those 25,000 units by the year 2025," said Councilman De Leon on Tuesday. "Everyone's on the hook. If anyone believes that it's the City Council's exclusive responsibility to deal with schizophrenia, bipolar disorder, to deal with deep entrenched systemic and generational poverty, or dealing with structural racism, they are delusional. That's why our friends in Congress have to step up and if not, they need to step out because it's all hands on deck today."

"There's an allocation of \$12 billion that's coming down the pipeline for the next two years. We can take advantage of all the vacancies through master leasing. We can do adaptive re-use by purchasing old buildings and converting them right away."

"Too many people have died on our streets and in our alleys. Last week it was 1,383 individuals who lost their lives... today we're making a significant decision that will begin to erase our city's most indelible mark of shame. The time for studying the crisis and hearing from experts, I believe, is over. Now is the time for action and delivering tangible results. Now is the time to get a roof over the heads of our unhoused neighbors and give them an opportunity to regain their lives and restore the pride of a great city."

A long-term homeless housing plan in LA

Council members agreed with De Leon, noting appreciation toward creating more housing rather than another homeless initiative that only studies the problem with no actual relief or housing.

"There's no question that the housing crisis is inextricably linked to homelessness, and I believe and I think it's the intent of de Leon to say precisely this: The best solution is to create more housing and a lot of it," added Councilman Mark Ridley-Thomas.

However, many also noted that new housing needs to be added more quickly despite the ambitious 2025 25,000

unit goal.

"We are seeking all creative solutions possible to address the problem, but we got to do more, and we got to do it quicker," said Councilmember Curren Price.

Critics also noted how unrealistic the plan was considering current homelessness levels, the recent major restrictions placed on homeless people in LA, and a projected rise in homeless people after

September 30th when eviction moratoriums end across the city, county, and state.

"25,000 units is a lot. There is no denying that," explained LA-based temporary housing placement advisor Lucy Skiles to the Globe on Wednesday. "But as good as long-term plans are, there is a lot of short-term concern, and the city is not addressing where

all of these people are going to go. Homeless can now effectively be moved from a lot of areas and the end of the eviction moratorium is coming. It's clear that the city does not want them, but there is a massive influx looming whether they like it or not and it needs to be addressed very

2. What was the name of Shakespeare's wife?

(Hint: She shares a name with the actress who plays Viola in the New York Shakespeare Festival's 2009 production of Twelfth Night.)

Anne Hathaway

Shakespeare was 18 when he was married, and his wife was 26 at the time. Six months after their marriage their first child Susanna was born. About two years later they had twins, Hamnet and Judith.

Hamnet passed away at age 11 of unknown causes.

3. How many sonnets did Shakespeare write?

154

Shakespeare is credited with 154 sonnets and approximately 38 plays. His plays have been translated into every major living language and have been performed more often than any other playwright.

How many times does suicide occur in Shakespeare's plays?

Suicide occurs an unlucky 13 times in Shakespeare's plays. It occurs in the iconic Romeo and Juliet where both leads commit suicide, in Julius Caesar where Brutus, Cassius, and Portia commit suicide, in Othello where Othello commits suicide, in Hamlet where Ophelia drowned, in Macbeth where Lady Macbeth dies, and finally in Antony and Cleopatra where suicide occurs five times (Antony, Cleopatra, Mark, Charmian, Eros, and Iras).

The Globe



Political affiliation plays a large role in determining each state's favored news sites. Blue states lean towards Google News and CNN, while red states overwhelmingly choose Fox News.

The Most Popular News Sites

Yahoo News is the most

popular news website in America, bringing in a massive **175 million** monthly suggests this trend extends visitors. In addition, they're the most searched-for news site in 12 states—the highest of any website. The company's history has been a roller coaster ride and at different times Yahoo intended to acquire Google and Facebook. Both companies went on to be worth over \$1 trillion each, while Yahoo shrank some 90% from when it was once worth \$125 billion.

The New York Times has 60 million monthly visitors, but in recent years, has pivoted towards the coveted and trending paid subscription model. This decision is paying off well, as the site now has 6.1 million paid subscribers—more than any of its competitors. Consequently,

the New York Times' share price hit a record high in December 2020.

HuffPost, and its audience of 110 million, were bought by BuzzFeed from Verizon in November of 2020. The two organizations have some history together, as BuzzFeed co-founder Jonah Peretti was also one of the early founders of HuffPost.

CNN is seeing a fall in ratings ever since Donald Trump left office. By some measures has witnessed a 36% decline in primetime viewers in the new

Google News experiences 125 million visitors a month, ranking second overall. That said, they stand tall relative to their competitors by overall visits to their main site. Here, Google hits 92.5 **billion** monthly visits, while Yahoo experiences more modest 3.8 billion. Unlike legacy media news companies, Google has managed to increase their

market share of U.S. advertising revenues, due to more ads going digital.

The Modern News Landscape

Overall, the modern news industry has been a tough landscape to operate in. Here are some of the reasons why:

First, the internet has removed barriers to where people obtain information, and

loved it and happily honked their horns as my employee spun his prop handguns at the drivers. After a n hour, I got a call from the LAPD who said, "John, this is the front desk of the police station. We just got a call from a

concerned citizen that there is a man pointing a gun at traffic on Topanga. Do you know anything about this?" Needless to say, I had to tell him to stop spinning the guns and just wave at people instead!

Putting such an eye-catching attraction on the street in front of my business was crucial

to getting the attention of commuters and any potential customers who might be passing by. But it wasn't enough by itself!

The second strategy was to get the attention of everyone

something exciting going on at Magic World!

Both of these strategies worked! Every day, the charming costume out front and the flashy tower of balloons in the sky would bring in new community over time, I still needed to constantly promote my store and let new customers know where to find me!

This lesson applies to all businesses. You need to always be looking for new ways to let your customers know that you are there. Keep your business on the top of their minds and you will always have customers, new and old, looking for your services. So... think of a new plan today to help people find your business and remind them that you are open!

The Cybersecurity Threats Facing Mobile Platforms In 2021

The usage of mobile devices has been growing on an annual basis. However, with the Covid-19 pandemic, mobile devices became essential tools for employees while working remotely. They are being used for Zoom team calls and also to access SaaS applications and sensitive company files. Hence it is no surprise when Analysys Mason states that "mobile device security will be the fastest-growing cyber security category in 2021." According to a 2020 report by Balbix, 99% of the



The Best Fast Break Lineups For The Lakers

The 2021-22 Los Angeles Lakers may take on a completely different identity than the Lakers of the previous two seasons. Their identity of the 2019-20 and 2020-21 seasons was that of a defensive powerhouse, ending as the third and first ranked defenses in terms of defensive rating in those two seasons, respectively. After adding Russell Westbrook, losing Alex Caruso, and adding a variety of aging veterans with the limited cap flexibility they had on hand, the Lakers seem to be positioning themselves for a drastic swing into the offensive direction.

The core of that likely offensive identity could be the team's fast breaks. With Russell Westbrook and LeBron James on the roster — two of the NBA's most exciting and aggressive transition players the Lakers could end up being one of the most enthralling and efficient transition teams in the NBA lending itself to a better offensive rating compared to last season's (109.8 ORTG – 24th in the NBA).

With that being said, I wanted to think of the best lineups that Frank Vogel could use to really activate the transition abilities of Russ and LeBron. In addition, I'm thinking of how these lineups could maximize the whole team's transition efficiency and volume. These lineups could help the Lakers pad some leads while wearing down opposing teams early in games.

Without further ado, I ranked the five best lineups that Vogel and the Lakers could use to activate the full potential of their fast breaks.

1. Russell Westbrook, Talen Horton-Tucker, Kent Bazemore, Carmelo Anthony, Marc Gasol

The first lineup I'm going with represents a theme that many are expecting for the Lakers this season: a sacrifice defense for better offense.

The addition of Westbrook immediately shows fans and analysts a vision of the Lakers with non-LeBron lineups that can score while The King gets some rest. What about Anthony Davis, though? One would assume that even though the Lakers have Westbrook, there will still be times where LeBron and Davis both sit on the bench. That's where this lineup comes in.

Although this lineup will lack in front-court athleticism with Anthony and Gasol at the four and five, respectively, its ability to switch on defense will allow it to wreak havoc with some deflections that will let Westbrook get out on the break. Although Gasol is limited by his lack of speed and size, he is still great at being an irritant to ball-handlers entering the lane with his ability to swat at the ball. Bazemore, meanwhile, is a pro at this and will be able to help create some steals on ball-handlers that may get past Westbrook and THT. Carmelo also has shown above-average ability.

Once they're out on the break, the lineup has two efficient rim-attackers in Westbrook and THT with Bazemore and Anthony filling out the wings and corners for some kickout threes. Also don't forget Gasol's ability to throw a great outlet pass, something we saw many times in last year's regular season.

2. Talen Horton-Tucker, Kendrick Nunn, Carmelo Anthony, LeBron James, **Dwight Howard**

Now, with my fifth-ranked fast-break lineup out of the way, let's get to one with LeBron James involved.

Although Westbrook is probably faster and more athletic than LeBron at this stage of their careers, Westbrook had a poor Stable Transition Points-Per-Possession rating from B-Ball



Index. This is from the efficiency (or lack thereof) that came from fast breaks led by Westbrook and LeBron as the former had an effective fieldgoal percentage of 53.7% on his transition shot attempts last season while the latter had an EFG% of 72.3%. Although the difference is drastic, it's not surprising when you consider Westbrook's reputation for being careless with the ball and LeBron's reputation as well — the opposite of that.

This is one I could see working as LeBron and Dwight Howard get to reunite in the frontcourt as they did many times for bench lineups during the 2019-20 season. Although THT is starting to seem more and more of a shooting guard than a point guard as his career progresses, he can occupy the 1 in this lineup as LeBron would more than likely be handling the ball on fast breaks anyways.

Although the defensive skill from THT and Nunn leaves a little to be desired, LeBron will likely be guarding a stretch four on the weak side, causing havoc in the paint as a ballhandler or a pass enters the lane. Howard will also serve as a much better rim protector than say Gasol would. And, of course, this lineup gives time to rest for Davis and Westbrook.

The most interesting part of this lineup is Nunn's ability to nail threes in transition, highlighted by Tom Zayas of the Lakers Exceptionalism podcast.


This Month In Sports History: September

September 3rd

On this day in 2008, Oklahoma City team officials unveiled the NBA team's new name and logo. The former Seattle Supersonics franchise is now known as the Oklahoma City Thunder. The team was acquired by Professional Basketball LLC from Starbucks founder Howard Schultz for \$350 million. Since moving to Oklahoma City, the team has made the playoffs nine times in total. During the 2011-12 season, the Thunder made the NBA Finals, losing to the Miami Heat in five games. Overall, the team has faced quite a few disappointing playoff exits in recent years. The 2015-16 season saw the Thunder blow a 3-1 lead in the Western Conference Finals, and consecutive first-round exits in the following three years.



September 12th

On this day in 1984, the Chicago Bulls signed Michael Jordan as their no. 3 draft pick. In his first year, Jordan was named as the Rookie of the Year after averaging 28.2 points, 6.5 rebounds, 5.9 assists, and 2.4 steals. It was apparent from the start that Jordan was going to be a superstar in the NBA, but he is also known for his accomplishments off the court. In the 15 seasons that Iordan played in the NBA, he became a cultural icon and transformed the Chicago Bulls into one of the most successful franchises in the league. As a player, Jordan led the Bulls to two three-peat championships. Jordan was a six-time NBA

Champion and was named NBA Finals MVP in all six finals. Jordan's accolades include being a 14x All-Star, 5x NBA MVP, 10x All-NBA First Team, 10x NBA scoring champion, 3x NBA steals leader, and NBA Defensive Player of the Year. Jordan attributed his incredible athleticism to Hollywood as the star in the film Space Jam, and his cultural cache fueled the success of Nike's Air Jordan sneakers. Jordan is currently the principal owner of the Charlotte Hornets, and he has a net worth of \$2.1 billion.



September 22nd

On this day in 1991, Miami Dolphins coach Don Shula recorded his 300th career NFL victory. The winningest coach in NFL history, Shula finished his coaching career

with 347 wins. The legendary coach recorded only two losing seasons in his 33-year coaching career and led six teams to the Super Bowl. Shula was best known for his time with the Miami Dolphins and the Baltimore Colts. Shula won his first championship coaching the 1968 Colts. In 1972, Shula coached the only perfect season in NFL history. The Miami Dolphins won Super Bowl VII against the Washington Redskins 14-7. The next season the Miami Dolphins repeated as Super Bowl champions under the leadership of coach Shula. They defeated the Minnesota Vikings 24-7. Don Shula was inducted into the Pro Football Hall of Fame in 1997.

Today, basketball has become the 5th most popular sport in the world and the Federation of International Basketball Associations estimated that a minimum of 450 million people plays the sport around the world. The growing legacy of the NBA has seen more than 400 inductees into the Basketball Hall of Fame. Nearly 200,000 people visit The Naismith Memorial Basketball Hall of Fame annually. The Hall is currently in a new phase of redesign, incorporating new advances in technology to enhance the fan experience. The continued promotion and preservation of the game will further grow the Naismith Basketball Hall of Fame as a place to celebrate one of the most beloved and quickest growing sports worldwide.



Supreme T-shirt Collection Looks To Fetch \$2 Million

With investors from most asset classes being rewarded for taking on risks over the last decade, it's not surprising to see money pour into other, less traditional assets.

We wrote in October about the strength in the sports card market, where data from PWCC—which manages the largest trading card auction venue in the world, shows the index of the top-performing 500 cards had a return on investment of 216% since 2008 compared to 135% for the S&P 500.

Then last week we wrote about the market for rare video games after a sealed copy of 1990's *Super Mario Bros. 3* fetched \$156,000 in an

auction, breaking the previous record—which was just set in July, for the most expensive video game ever sold.

The latest example of collectibles with a cult following potentially bringing top dollar comes from auction house Christie's, which is holding its first dedicated auction to the streetwear brand Supreme, which agreed to be acquired by VF Corporation last month. Bidding for "Behind The Box: 1994-2020" began on December 1 and runs through December 15.

The auction, which was curated by Supreme historian Ross Wilson, features some of the most iconic Supreme items and contains rare products, non-released samples, and comprehensive full sets from the label's entire 26-year history.

Alongside "Behind The Box: 1994-2020," Christie's is selling the only known complete set of Supreme Box Logo T-shirts ever curated, known as The Box Logo Collection. The collection of 253 different Box Logo T-shirts is expected to go for around \$2 million, making it the most valuable collection of Supreme items to ever be offered in a single sale.

The collection was curated by 21-year-old James Bogart who began collecting the T-shirts when he was just 14 years old. Bogart, who admits the \$2

million figure is "ridiculous," made it his goal to curate the first "complete archive" after buying his first T-shirt.

Bogart didn't say how much he spent to assemble the collection of Box Logo T-shirts, but a response to a question on his site's FAQ details how much time it took to find them all.

"It's been a non-stop 5-year hunt to accumulate this collection," Bogart said. "A lot of people don't think about the non-stop weeks, months, and even years of research and work that it can take to find just one tee."

Bogart, who is now studying business and fashion in Italy, will be both sad to see the collection go but clearly happy to cash in.

"I think it'll be a little bit bittersweet," Bogart said about selling the collection. "For me, it was always about the hunt. And the fact that so many people deem this collection impossible to be completed. So once it was completed, there was a sense of great relief and great pride, but I really did want to put it on a stage where it could be appreciated and do the collection justice."

If the collection sells, Bogart wants the buyer to do "whatever makes them happy," but would prefer they don't wear the T-shirts.

"I hope that they don't wear them," Bogart said. "I've spent so long trying to get these shirts in their best possible condition. I think it would be a little bit painful to watch."

As money floods into more unusual assets such as sports cards, video games, and Supreme items, it's a great time to be the owner of rare collectibles that have developed a cult following.

The Colonial Pipeline Ransomware Hackers Had A Secret Weapon: Self-Promoting Cybersecurity Firms

Five months before DarkSide attacked the Colonial Pipeline, two researchers discovered a way to rescue its ransomware victims. Then an antivirus company's announcement alerted the hackers.

On Jan. 11, antivirus company Bitdefender said it was "happy to announce" a startling breakthrough. It had found a flaw in the ransomware that a gang known as DarkSide was using to freeze computer networks of dozens of businesses in the U.S. and Europe. Companies facing demands from DarkSide could download a free tool from Bitdefender and avoid paying millions of dollars in ransom to the hackers.

But Bitdefender wasn't the first to identify this flaw. Two other researchers, Fabian Wosar and Michael Gillespie had noticed it the month before and had begun discreetly looking for victims to help. By publicizing its tool, Bitdefender alerted DarkSide to the lapse, which involved reusing the same digital keys to lock and unlock multiple victims. The next day, DarkSide declared that it had repaired the problem, and that "new companies have nothing to hope for."

"Special thanks to BitDefender for helping fix our issues," DarkSide said. "This will make us even better."

DarkSide soon proved it wasn't bluffing, unleashing a string of attacks. This month, it



paralyzed the Colonial Pipeline Co., prompting a shutdown of the 5,500-mile pipeline that carries 45% of the fuel used on the East Coast, quickly followed by a rise in gasoline prices, panic buying of gas across the Southeast, and closures of thousands of gas stations. Absent Bitdefender's announcement, it's possible that the crisis might have been contained, and that Colonial might have quietly restored its system with Wosar and Gillespie's decryption tool.

Instead, Colonial paid DarkSide \$4.4 million in Bitcoin for a key to unlock its files. "I will admit that I wasn't comfortable seeing money go out the door to people like this," CEO Joseph Blount told The Wall Street Journal.

The missed opportunity was part of a broader pattern of botched or half-hearted responses to the growing menace of ransomware, which during the pandemic has disabled businesses, schools, hospitals, and government agencies across the country.

The incident also shows how antivirus companies eager to make a name for themselves sometimes violate one of the cardinal rules of the cat-and-mouse game of cyber-warfare: Don't let your opponents know what you've figured out. During World War II, when the British secret service learned from decrypted communications that the Gestapo was planning to abduct and murder a valuable double agent, Johnny Jebsen, his handler wasn't allowed to warn him for fear of cluing in the enemy that its cipher had been cracked. Today, ransomware hunters like Wosar and Gillespie try to prolong the attackers' ignorance, even at the cost of contacting fewer victims. Sooner or later, as payments drop off, the cybercriminals realize that something has gone
